Dear Mr. Edgell:

On April 27, 2011, Ohio EPA inspected Edgell-Jackson Trucking ("EJT") in Marietta, Ohio to determine EJT's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). EJT was represented by you. This letter will explain the violations I found, what you need to do to correct the violations, other general concerns we have, what you need to do to respond to my general concerns and any pollution prevention opportunities I identified.

I found the following violations of Ohio's hazardous waste laws. In order to correct these violations, you must do the following and send me the required information **within 30 days** of the date of this letter:

- (1) **OAC Rule 3745-279-22,(C), Used Oil Storage Requirements for Generators:**
(C) Containers and tanks of used oil must be labeled with the words "Used Oil";

A container of used oil in your maintenance garage was not labeled. During the inspection, you labeled the container; therefore, this violation has now been abated.

- a. EJT generates spent fluorescent lamps which may be a universal waste. Please refer to the following information when managing your spent lamps:
