
Actions Required As A Result of the Above Violation	
Step 1	<p>Within 30 days issue the attached public notice of the violation in accordance with Rule 3745-81-32 of the Ohio Administrative Code by the following methods:</p> <ol style="list-style-type: none"> Continuous posting, mail, or other direct delivery; and If necessary, the system must also use any other method reasonably calculated to reach all persons served by the water system. <p>The language in italics on the attached public notice is mandatory and must be included as written.</p>
Step 2	<p>Within ten (10) days of completing Step 1 above, fill out the attached verification form and send along with a copy of the public notification issued to the Southwest District Office of the Ohio EPA.</p>

If samples were taken, we have not received the results. Please forward a copy of the results to my office. Late reporting is a reporting violation, but if the sample was taken you will not need to post the attached public notice.

DRINKING WATER NOTICE

Monitoring requirements not met for the THE DOLL HOUSE

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During October - December 2007, we did not monitor or test for total coliform bacteria, and therefore cannot be sure of the quality of your drinking water during that time.

What Should I Do?

There is nothing you need to do at this time. You do not need to boil your water or take other corrective action.

This notice is to inform you that the THE DOLL HOUSE did not monitor and report results for the presence of total coliform bacteria in the public drinking water system during the October - December 2007 time period, as required by the Ohio Environmental Protection Agency.

What is being done?

Upon being notified of this violation, the water supply was required to have the drinking water analyzed for the above mentioned parameters. The water supplier will take steps to ensure that adequate monitoring will be performed in the future.

**PUBLIC NOTICE INSTRUCTIONS AND VERIFICATION FORM FOR
NONCOMMUNITY PUBLIC WATER SYSTEMS WITH TIER 3 VIOLATIONS**

The owner or operator of a noncommunity public water system with a Tier 3 violation or situation shall notify the persons served by the public water system as soon as practical but **no later than 30 days** after the system learns of the violation, unless the notice is included with the next bill to customers, then the notice shall be distributed no later than 90 days from the date of the violation. Public notice issued by posting shall remain in place as long as the violation or situation persists. Public notice issued by other methods shall be repeated annually as long as the violation or situation persists.
