This letter is written in follow-up to a construction storm water inspection by Amber Miller and Sean Tyler, of the Ohio EPA, conducted at Next Level Fitness located at 720 Cross Pointe Road on July 23, 2009. The purpose of the inspection was to evaluate compliance with the General Storm Water Permit Associated with Construction Activities. During the inspection, the following items were noted:

It appeared that construction activity has been completed for this site and all disturbed areas had been permanently stabilized. A Notice of Termination will be required provided the post construction requirements are met. Please address the following:

- The General Storm Water Permit requires specific post construction water quality treatment for all sites.
