Re: Preliminary Storm Water Inspection at State Industrial Products

Dear Operations Manager:

This letter is written in follow-up to a preliminary storm water inspection I conducted at State Industrial Products located in Hebron, Ohio on February 22, 2010. This facility may require coverage under Ohio EPA's General Storm Water Permit Associated with Industrial Activities. In accordance with current storm water regulation, the following items are noted:

Storm Water Permitting Requirements:

- In accordance with 40 CFR 122.26 and OAC 3745-39-04, this facility appears to require coverage under the "General Storm Water Permit Associated with Industrial Activities." The general permit is a National Pollutant Discharge Elimination System (NPDES) permit which authorizes the release of storm water associated with your facility. The Notice of Intent (NOI) application and permit can be found at the following address: <http://www.epa.state.oh.us/dsw/storm/stormform.aspx> The SWPPP must be developed prior to the submittal of the NOI application.
- Facilities with specific Standard Industrial Classification (SIC) codes are mandated, under federal and state law, to obtain coverage under the General Storm Water Permit. The intent of the permit requires the facility to assess process and externally stored materials which may pose a threat to storm water run-off. As a result the facility must implement Best Management Practices to reduce the potential threat of storm water contamination.

Storm Water Pollution Prevention Plan (SWPPP):

- In the event a General Permit is required for this facility, a SWPPP must be developed specific for this site. The SWPPP must include a site map which clearly delineates all storm water drainage patterns. All storm water outfalls/discharges from the site must be identified on the SWPPP. All Best Management Practices (BMP's), current and future, must be inclusive in the SWPPP and site map. The SWPPP must be reviewed and updated on a yearly basis to reflect any changes at this facility. Guidance documents for preparing a SWPPP can be found at:

NO Exposure Certification (NOE)

- In the event you do not have materials or processes outside, but are mandated to obtain coverage based on your SIC Code, you can file a "No Exposure Certification" (NOE). The NOE is a conditional exemption from permitting. The NOE must be re-submitted every five years to reflect potential operational changes at the facility.
