This letter is written in follow-up to a construction storm water inspection that I conducted at the East Landings, Sec. 1, located in the northwest corner of the intersection of Refugee Road and Hamilton Road on September 16, 2010. The purpose of the inspection was to evaluate compliance with the General Storm Water Permit Associated with Construction Activities. During the inspection, I noted the following:

Sediment Controls and Maintenance:

- Upon inspection, there were several barren home lots and the lots did not have erosion controls. Please have silt fence or straw waddles placed around the perimeter of the lot and stabilize the barren areas. Please see attached picture.
- The concrete wash pit was in need of repair. Please repair the concrete wash pit immediately. Please see attached picture.
- Maintenance of Controls: The sediment controls implemented on this site, including the concrete washout, will require maintenance or reinstallation to ensure a proper functioning condition. This general permit states that all sediment controls will be inspected and maintained every seven days or within 24 hours of a precipitation event equal to or greater than 0.5 inches. A log of inspection must be maintained on site for the agency to review. The log that was on-site was not up-to-date.


