Dear Mr. Heiss:

On March 7, 2012, Ohio EPA inspected Heiss Refinish and Repair ("HRR") in Waterford, Ohio to determine compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

I found the following violations of Ohio's hazardous waste laws:

- (1) OAC Rule 3745-279-22 (C), Used Oil Storage Requirements for Generators:**
(C) Containers and tanks of used oil must be labeled with the words "Used Oil".

During the inspection, I observed that HRR had four unlabeled drums of used oil. These were properly labeled during the inspection. Therefore, HRR has now abated this violation.

GENERAL COMMENTS

- A.** Your company generates less than 20 gallons per month of spent paint/thinner (F003/F005 hazardous waste) from the cleanout of paint guns in your paint booth. According to you, spent thinner is typically added to your used oil drum. When full, the drum is transported by you to your home, which is on contiguous property, and burned in a space heater in the garage/shop at your residence. This is considered an "on-site" space heater. I did not observe used oil being actively burned at your residence during my inspection.

Please note that as a business that generates used oil, the following rules apply to how you manage your used oil. Please immediately take steps to comply with these prior to burning any more used oil at your home:

1. Mixing small quantities of hazardous waste into your used oil is permissible at your business so long as you generate no more than 27.5 gallons per month of hazardous waste.
2. Used oil generated by your business may not be burned in a space heater unless you have done the proper analysis to determine that your used oil is not contaminated with excess levels of hazardous waste (such as spent paint/thinner) that you have mixed into it. Usually the demonstration that the used oil meets the specification levels in OAC rule 3745-279-11 is made by analysis of a representative

sample of the used oil for the constituents listed in the rule. This may cost around \$200 per sample. If you choose to burn used oil only (not mixed with paint/thinner waste), as you stated during our March 8, 2012 telephone call, you must containerize and send your thinner/paint waste offsite to a permitted hazardous waste treatment, storage or disposal company (TSD). Please see the attached information on how to choose a TSD. A list of TSDs that can accept your hazardous waste can be found at http://www.epa.ohio.gov/dhwm/receiving_facilities.aspx


3. More information on burning used oil in space heaters is enclosed.
4. If you decide to no longer burn your used oil at your residence, you must send the used oil generated by your business to a registered used oil recycler. A list of these can be found at the following link. Note that you must maintain in your files receipts for all offsite shipments of used oil.

5. If you decide to send your used oil off-site, you may self-transport no more than 55 gallons at a time of your used oil in your company vehicle or your own vehicle or that of one of your employees. If you have your used oil transported by someone other than as described above, the transporter must have obtained a USEPA ID number.
- B.** Over the past several years, your company has generated and stored onsite approximately 41 super sacks (approximately 82 tons) of spent sandblasting media. Based on your process knowledge, this is a solid waste. This waste must be sent either to a licensed solid waste landfill or reused in accordance with Ohio EPA guidance. This matter has been referred to Joe Holland, a solid waste inspector with the Division of Materials and Waste Management at Ohio EPA for follow up. He can be reached at 740-380-5439.
