
On May 14, 2008, I conducted a site visit to your company, which is located at your home at 357 Buck Hollow Road, Lucasville, Ohio in order to determine your progress with compliance with the enclosed Notice of Violation (NOV) letter that I had mailed to you on May 6, 2008. During the site visit, you stated that you had not received the attached NOV letter nor a previous one sent on March 11, 2008. You claimed that your address is 357 Buck Hollow Road, not 537 Buck Hollow Road, the address to which previous letters have been sent. The two addresses are located several hundred feet away from each other, and the Scioto County Auditor's office lists you as the property owner of 537 Buck Hollow Road. Even though you said you did not receive the letters, you seemed to have thorough knowledge of the content of these letters, and the letters were never returned to Ohio EPA as undeliverable, leading me to believe that you indeed did receive the letters. Nevertheless, I stated on my May 14, 2008 site visit that I would fax the letter to you and give you an additional 30 days from the date of my site visit to comply. I faxed the letter to you on May 16, 2008. In addition, I am resending the enclosed letter to you via certified US Mail.

Please respond to the attached letter **no later than June 16, 2008**. Should you fail to **abate the violations in the manner described in the attached letter**, your company will be subject to escalated enforcement consideration which could include fines and penalties for these and other chronic violations of Ohio's hazardous used oil laws. Note that fines and penalties may be calculated for each day that your company has failed to comply with the regulations.
