This letter is written in follow-up to a construction storm water inspection by Vinod Tujalpuram and Jed Plank of the Ohio EPA, conducted at **Scioto Audubon Metro Park** located on West Whittier Street in Columbus, Ohio on August 09, 2010. The purpose of the inspection was to evaluate compliance with the General Storm Water Permit associated with Construction Activities.

It appeared during the inspection that construction activity is completed for this site. A Notice of Termination will be required provided the following requirements are met.

- Vegetation must be established sufficient to control erosion which is measured by a minimum vegetative density of 70%.
- The General Storm Water Permit requires specific post construction water quality treatment for all sites. Guidance regarding the post construction mandates can be found at:
