Dear Mr. Foster:

On July 30, 2008, Robert Almquist and I investigated a complaint at Dan Foster Auto Recycling in Ravenna, Ohio. The complainant alleged that waste petroleum products and crushed automobile batteries were being improperly disposed. The complainant also alleged that the facility failed to notify state officials about hazardous waste spills. It was raining slightly during the inspection. You initially met Ohio EPA and answered questions about the facility. After lunch we returned and Gary Travis accompanied us on an inspection of the facility. In the week following the inspection several hazardous waste, used oil, and universal waste fact sheets and lists of recyclers were sent to you. This letter will explain the validity of the complaint.

Violations:

1. **Used Oil Containers Labeled:** OAC 3745-279-22(A) Used oil containers were not labeled with the words "Used Oil".

We observed that used oil was being stored in an orange vertical tank. You stated that the orange tank was pumped out at the time. We supplied a used oil label for the orange tank. There was also a bucket containing used oil inside the workshop shed. The bucket was not labeled. You stated that the business generates about five drums of used oil every six or eight months. Please label the used oil containers with the words "used oil" and submit photos that document this to Ohio EPA.

2. **Universal Waste Batteries Labeled:** OAC 3745-273-14(A) Universal waste batteries were not labeled with the words "Universal Waste – Batteries" or "Waste Battery" or "Used Battery."

During the inspection many used batteries were observed both inside the shed and outside in the yard. Some batteries were on pallets and some batteries were scattered in the yard. The batteries were not labeled as described above. Please appropriately label the used batteries and document this by submitting a photograph to Ohio EPA.

Comments:

1. We were unable to determine if the used oil is hauled only by transporters that have obtained a U.S. EPA Identification number. At the time of the inspection you stated that you would look for the receipts, waste manifests, or bill of lading for the used oil. You stated that the used oil was taken by Safety Clean. Ohio EPA has not received any used oil paperwork. We gave Mr. Travis a used oil fact sheet.

Please submit the used oil management paperwork to Ohio EPA.

2. During the inspection many used batteries were observed both inside the shed and outside in the yard. You stated that the used batteries are picked up by a guy in Ashland. You stated that you would look for the paperwork documenting the used battery destination in Ashland. We were unable to determine the accumulation time of the batteries without the paperwork. Please submit to Ohio EPA any information you have regarding the used battery accumulation time and off-site management.
3. Please note that universal waste batteries must be managed in a way that prevents release of any universal waste or component of a universal waste (electrolyte, acid) to the environment. The casing of each battery cannot be breached and must remain intact and closed. (except that cells may be opened to remove electrolyte but must be immediately closed after removal). The electrolyte must be managed appropriately and not dumped on the ground. Universal waste batteries cannot simply be crushed or cracked which would result in fluid leaking from the battery.
4. Mr. Travis stated that waste gasoline which contains contaminants and cannot be used for its original purpose is collected in a drum. The waste gasoline drum was not labeled. Mr. Travis stated that a place in West Virginia takes the waste gasoline when there is 250 gallons accumulated. Please determine where the waste gasoline is taken and how it is managed. Please submit this information to Ohio EPA.

Ohio EPA, Division of Hazardous Waste Management did not find evidence to support the complaint during the inspection. Ohio EPA was unable to confirm a hazardous waste spill.

Ohio EPA's failure to list specific deficiencies or violations in this letter does not relieve your company from having to comply with all applicable regulations.

Ohio EPA has attached a guidance document regarding universal waste management. Universal wastes include batteries and florescent lamps. Universal wastes (UW) are specific hazardous waste streams that a generator can choose to manage in an alternative manner in place of the more complex hazardous waste requirements. These wastes are encouraged to be recycled rather than disposed of as hazardous waste.

You may be able to reduce the waste your company generates. If you find ways to recycle, reduce or eliminate the amount of waste that your company generates, you may be able to reduce treatment and disposal costs as well as regulatory requirements. If you would like a free, non-regulatory, on-site compliance assistance or pollution prevention assessment, or if you would like more information about pollution prevention, please contact Adrienne LaFavre at (330) 963-1250.
