Dear Mr. Bley:

On December 16, 2011, Ohio EPA received Spring Grove Resource Recovery's (SGRR) response to the November 17, 2011, notice of violation letter. Based on the information provided, SGRR has adequately demonstrated abatement of the following violations cited in the November 17, 2011, letter:

1. **Duty to Comply, Condition A.5 and OAC 3745-50-58(A)**
2. **General Waste Analysis Plan, Condition B.3 and OAC 3745-54-13**

Section E of Clean Harbors' profile sheet states, "If based on knowledge, please describe in detail, the rationale to identify and characterize the waste material. Please include references to Material Safety Data Sheets (MSDS) when applicable. Include the chemical or trade-name represented by the MSDS, and or detailed process or operating procedures which generate the waste." Profile CH504872 listed "generator knowledge" and nothing else. SGRR has been informed repeatedly that simply typing in "generator knowledge" is not acceptable representation of the generator's knowledge. Profiles that do not adequately describe the generator's knowledge will be flagged as violations.
