Dear Mr. Clark:

On January 25, 2012, the Ohio Environmental Protection Agency (Ohio EPA) conducted a compliance evaluation inspection of Allied Moulded Products, Inc. (AMPI) located at 222 North Union Street in Bryan, Ohio. I inspected AMPI to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). Pollution prevention options were also discussed during this inspection. This letter will explain the violations I found and your compliance with respect to each.

During my visit, I spoke with you and Brad Rupp, inspected your facility operations, and reviewed applicable paperwork. AMPI manufactures fiberglass electrical boxes and enclosures using compression and injection molding.

Used oil is generated as a result of the production equipment and is stored in totes. Used oil is picked up once a month for recycling by Cousins. The used oil is burned for energy recovery. AMPI has one parts washer that is serviced by Heritage Crystal Clean and is part of their continued use program.

AMPI generates spent gun flush that is used in the QA/QC resin testing lab. AMPI ships the spent gun flush to Petro Chem as a non-hazardous combustible liquid (flashpoint of 170°F) that is burned for energy recovery. AMPI also generates spent fluorescent bulbs that are managed as universal waste. The universal waste is picked up for recycling by Cousins. At the time of my inspection, AMPI was operating as a non-generator of hazardous waste.

I found the following violations of Ohio's hazardous waste laws:

1. OAC Rule 3745-279-22(C)(1): Labeling:

Containers, aboveground tanks, and fill pipes used for underground storage tanks shall be labeled or marked clearly with the words "used oil."

AMPI had six totes of used oil in the water tower room and one tote of used oil in the maintenance area that were not properly labeled.

At the time of my inspection, AMPI properly labeled the one used oil tote located in the maintenance area with the words "used oil". A copy of the fact sheet, The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil, was given to you at the time of my inspection. Please review this information and contact me if you have any questions.

On January 26, 2012, AMPI submitted photographic documentation showing the six used oil totes located in the water tower room now properly labeled with the words "used oil".

With this information, this violation has been abated.

2. OAC Rule 3745-273-13(D)(1): Universal Waste: Fluorescent Lamp Management:

All lamps/bulbs being managed as a universal waste must be stored in packages that are structurally sound and adequate to prevent breakage. The packages/containers must be closed.

AMPI did not store the spent universal waste fluorescent lamps in containers that were closed. Specifically, AMPI had one open box of spent mercury vapor bulbs and one open cardboard container of spent fluorescent tube lamps.

On January 26, 2012, AMPI submitted photographic documentation showing the box and container of spent fluorescent bulbs/lamps now properly closed.

With this information, this violation is considered abated.

3. OAC Rule 3745-273-14(E): Universal Waste: Fluorescent Lamp Labeling:

All packages and containers holding spent fluorescent lamps/bulbs are to be labeled with the words "Universal Waste - Lamps", "Waste Lamps" or "Used Lamps".

AMPI did not have the box of spent mercury vapor bulbs properly labeled.

On January 26, 2012, AMPI submitted photographic documentation showing the box of spent mercury vapor bulbs now properly labeled.

With this information, this violation is considered abated.

4. OAC Rule 3745-273-15(C): Accumulation Time for Universal Waste Batteries and Lamps:

A small quantity handler of universal waste shall be able to demonstrate the length of time that the universal waste has been accumulated from the date it becomes a waste or is received.

AMPI was unable to demonstrate the length of time the box of mercury vapor universal waste bulbs have been on-site. In order to correct this violation, AMPI must immediately ship off-site for recycling the spent fluorescent bulbs that have been in storage for greater than one year. AMPI must submit a copy of the receipt for the shipment of spent fluorescent bulbs sent off-site for recycling. In addition, AMPI must submit a copy of an internal written policy that ensures the one year storage time is not exceeded.

5. OAC Rule 3745-273-16: Universal Waste Employee Training:

A small quantity handler of universal waste shall ensure that all employees are thoroughly familiar with proper waste handling and emergency procedures, relative to their responsibilities during normal facility operations and emergencies.

AMPI has not ensured that all employees are thoroughly familiar with proper universal waste handling and emergency procedures.

In order to correct this violation, AMPI must describe, through a training outline, how it will thoroughly familiarize (train) its universal waste fluorescent bulb handlers in proper handling and emergency procedures. AMPI must submit some form of documentation demonstrating that this training has been accomplished. The training must also include compliance with all rules for the handling of universal waste bulbs and the corrective actions for all violations of universal waste rules, cited above. A copy of Fluorescent Lamps: What You Should Know, was given to you at the time of my inspection. I recommend that you and your employees review this document and contact me if you have any questions.

Enclosed you will find a copy of the checklists that were completed during the inspection.

AMPI needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, AMPI is requested to provide documentation to this office including the steps taken to abate the violations cited above. Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to melissa.boyers@epa.ohio.gov.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734. of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation.


