
Dear Mr. Conter:

On Wednesday, January 25, 2012 I was on your property to observe and document open burning for the purposes of waste disposal. An unattended fire was producing significant quantities of white smoke and other pollutants. Photos on reverse.

Please be advised that this fire was in violation of Ohio Administrative Code Rule 3745-19-03 and possibly other code violations regarding unattended fires.

There will be no fines or other Ohio EPA enforcement at this time but be aware that fines of \$250 per day per violation can be assessed if these violations continue.




