Dear Mr. Geyer:

Country Haven Mobile Home Park public water system (PWS) has violated Ohio's safe drinking water law. Specifically, the PWS failed to monitor for arsenic, total coliform, lead and copper, total trihalomethanes (TTHM), and haloacetic acids, five (HAA5); failed to prepare and mail or otherwise directly deliver Consumer Confidence Reports (CCR); failed to submit plans prior to installing a filtration system; and has failed to issue public notices.

**Owners or operators of public water systems that fail to comply with Ohio's safe drinking water laws and regulations are subject to civil penalties of up to \$25,000 per day per violation under Ohio Revised Code Section 6109.33.**

To resolve your drinking water violations and avoid possible legal action and civil penalties, it is agreed that Country Haven MHP will:

1. Within thirty (30) days of the date of this letter, issue public notification and submit copies of the required public notice and verification form in accordance with OAC Rule 3745-81-32, to the Ohio EPA, Division of Drinking and Ground Waters (DDAGW), Central Office (CO), Lazarus Government Center, P.O. Box 1049, Columbus, Ohio 43216-1049, for failing to collect a total coliform sample during the month of March 2003; for failing to monitor for arsenic during the January to March 2006, April to June 2006, July to September 2006, and October to December 2006 monitoring periods; and failing to monitor for total trihalomethanes and haloacetic acids, five during the April through June 2006, October through December 2006, and April through June 2007 monitoring periods.
2. Comply with all current and future contaminant monitoring schedules issued by the Director.


3. Prepare and mail or otherwise directly deliver an annual CCR to each customer, in accordance with OAC Chapter 3745-96.
4. Collect a sample for arsenic analysis quarterly, in accordance with OAC Rule 3745-81-23 and your current contaminant monitoring schedule.
5. Address any comments or deficiencies noted by Ohio EPA on any plan or other documentation submitted by Country Haven MHP, Within thirty (30) days of notification,
