
On October 19, 2010, Ron Shadrach and I, representing the Ohio EPA's Division of Hazardous Waste Management, conducted a complaint investigation of your facility located at 1350 Kelly Avenue, Akron, Ohio. The complaint alleges that used oil is leaking from an underground storage tank and surfacing about 50 feet from the southern end of the building.

During the inspection, it was determined that the facility generates used oil from truck maintenance. The oil is accumulated in drums and a 250 gallon above ground tank located next to the oil burner. The tank and drums of oil were not properly labeled "Used Oil" which is a violation of **Ohio Administrative Code (OAC) Rule 3745-279-22(C)(1)**. Fleet Maintenance Service must label the containers "Used Oil" and submit photographic documentation to demonstrate compliance with this rule within 30 days of the date of this letter.

An inspection of the last bay did not reveal evidence of an underground tank as the complainant alleged. We also inspected the outdoor area south of the last bay. Several small areas of a thick tar like substance were on the ground. As discussed, this material should be picked up and disposed as a solid waste. Please submit a picture of the area after this waste has been removed and disposed. At the time of the inspection, it did not appear that used oil was being improperly disposed.
