Dear Mr. Bell:

Thank you for accompanying me during Ohio EPA's April 29, 2011, inspection of the Lusty Wrench facility in Cleveland Hts., Ohio. I inspected Lusty Wrench to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). My inspection included a review of company operations and written documentation. During the inspection I also helped you identify ways to prevent pollution by reducing waste.

Lusty Wrench is an auto repair shop specializing in mechanical repairs. The facility currently generates one hazardous waste stream, spent carburetor cleaner (F001), from a parts washer serviced by the Kwik-Kleen Company. The facility's rate of generation makes Lusty Wrench a conditionally exempt small quantity generator of hazardous waste.

In addition to the inspection for compliance with Ohio's hazardous waste rules, the facility was inspected for compliance with Ohio's used oil rules and universal hazardous waste rules.

The following violations of Ohio's hazardous waste and used oil rules were found during this inspection. In order to correct these violations you must do the following and send me the required information **within 30 days** of the date of this letter:

**1. Waste Evaluation, OAC 3745-52-11:**

Any person who generates a waste must evaluate the waste to determine if it is a hazardous waste in accordance with the criteria set forth in OAC Chapter 3745-51. Lusty Wrench violated this regulation by disposing of waste lamps (primarily fluorescent lamps) as solid waste without determining whether or not the waste lamps are a hazardous waste. The waste fluorescent lamps contain mercury and may contain other hazardous metals. These may therefore be a hazardous waste. To abate this violation, submit documentation of Lusty Wrench's evaluation of the waste lamps and batteries in compliance with Ohio's hazardous waste regulations.


**As an alternative to determining whether your particular waste lamps are hazardous waste, you may wish to manage them as Universal Waste.** In general, this would involve saving the waste lamps in a properly labeled and closed container and having them recycled by a lamp recycler (see enclosure *Universal Waste*). If Lusty Wrench chooses to manage the waste lamps as Universal Waste and recycle the lamps through an approved lamp recycler, indicate this in your response letter.

**2. Used Oil Labeling, OAC 3745-279-22 (C):**

All containers, above ground tanks, and fill pipes used for underground tanks that are used to accumulate used oil must be clearly labeled or marked "Used Oil." At the time of my inspection the 55 gallon drums accumulating used oil observed at the facility did not have any marking indicating used oil. This is a violation of OAC 3745-279-22(C). To return to compliance with this rule, submit a photograph of the used oil tank labeled "used oil."
