Dear Mr. Lorenz:

Thank you for accompanying me during Ohio EPA's August 27, 2009, compliance inspection of Kowalski Heat Treating Company (KHT) at 3611 Detroit Ave., Cleveland, Ohio. I inspected KHT to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). KHT was represented by you and Mr. Stephen Kowalski. The facility is a heat treating company which anneals metal parts using either a vacuum purge method or a salt bath method.

KHT generates spent trichloroethylene (F001) hazardous waste from a vapor degreaser. This vapor degreaser is used sporadically and is picked up directly from the unit, and recycled by Chemical Solvents, with no on-site accumulation. The facility is a conditionally exempt small quantity generator. No hazardous waste was on site at the time of the inspection.

During my investigation, I also inspected KHT for compliance with Ohio's used oil rules. KHT was found to be in violation of the following universal waste rules found in Chapter 3745 of the Ohio Administrative Code:

1. **Waste Evaluation, OAC 3745-52-11:** KHT failed to evaluate spent fluorescent lamps prior to disposal as a solid waste. You must evaluate these wastes to determine if they are hazardous wastes. To abate this violation, submit documentation concerning the evaluation and proposed management of the lamps at your facility. Please note that you may manage the spent fluorescent lamps as a Universal Waste under OAC Chapter 3745-273.
