Dear Mr. Dowd:

The Ohio EPA Division of Hazardous Waste Management (Neil Wasilk and Robert Almquist) conducted an inspection of Jasar Recycling Inc. (Jasar) located at 278 West Taggart Street, East Palestine, Ohio on June 20, 2007. I sent you a letter dated June 29, 2007, which cited violations and concerns found during that inspection. Jasar has documented a correction of all the violations as outlined below.

**Violations:**

1. Ohio Revised Code (ORC) 3734.02(E) and (F) – Disposal of hazardous waste.  
Our November 27, 2007 telephone conversation and the November 14, 2007 hazardous waste manifest you faxed me document that the acid-contaminated limestone resulting from this disposal has been shipped off site.
2. OAC rule 3745-279-22(C) - Used oil labels.  
Previously corrected.
3. OAC rule 3745-279-22(D) - Response to releases of used oil.  
Your July 27, 2007 letter and the July 30, 2007 shipping paper document your correction of this violation.

**Concerns:**

Your July 27, 2007 letter addressed all the concerns listed in my June 29, 2007 letter.


