Dear Mr. Hill:

On August 10, 2007, Ed D'Amato and I met with Guy at JR's Trucks located at 16606 S. Waterloo Road, in Cleveland, Ohio. As outlined below, you have corrected all the violations found during my May 31, 2005 inspection.

1. OAC rule 3745-279-22(B) - Condition of used oil storage units. Previously corrected.
2. OAC 3745-279-22(C) - Used oil labels.
On August 10, 2007, a drum of used oil and two drums of waste deisel fuel (which will be put into the used oil tanks) were not labeled. Guy then labeled these at the time of the inspection. This shows your correction of this violation.
3. OAC 3745-279-22(D) - Response to releases of used oil.
You have cleaned up the previously seen releases of used oil which shows your correction of this violation. If new releases occur, they must be cleaned up immediately.
4. OAC rule 3745-279-22(B) - Condition of used oil storage units. (Violation found during November 1, 2005 inspection.)
The two new used oil tanks were seen to be in good condition. The old used oil tank was still in use. However, it was not filled to a level close to the side hatch which could cause it to leak. This shows your correction of this violation.

I have included the following information regarding electrical switches containing mercury:

Mercury switches were used for convenience lighting in hoods and trunks and in anti-lock braking systems of many vehicles manufactured until 2003. If these mercury switches are left in vehicles that are crushed and shredded, the mercury will be released to the air. Information on a current recycling program for these switches is enclosed and can also be found at:


