Dear Mr. Hammond:

On July 29, 2009, Sherry Slone and I, of the Ohio EPA's Division of Hazardous Waste Management (DHWM), made a site visit to conduct a compliance evaluation inspection of Valley Industrial Trucks, Inc. at 1620 East Market St. in Akron, Ohio. This inspection was conducted to determine compliance with Ohio's hazardous waste laws and regulations, as found in the Ohio Revised Code and the Ohio Administrative Code ("ORC" and "OAC" respectively).

At the time of inspection DHWM reviewed facility operations and waste streams, performed a walkthrough inspection of indoor and outdoor areas, and requested facility documentation records to review. From the inspection and records review it appears that you are a conditionally exempt small quantity generator (CESQG) of hazardous waste.

The following violations of Ohio's hazardous waste rules and regulations were identified during the inspection:

1. **Waste Evaluation, OAC 3745-52-11:** Any person who generates a waste must evaluate the waste to determine if the waste is a hazardous waste in accordance with the criteria set forth in OAC Chapter 3745-51. Lamps were reported disposed to the trash. You failed to evaluate spent lamps.

This violation was abated when you indicated you would manage all lamps as a universal waste and labeled two spent lamps as universal waste.

Spent fluorescent and high intensity discharge lamps may be considered hazardous waste due to their mercury, lead and other metal content and must be disposed or recycled properly.

Spent lamps that are recycled are not subject to the hazardous waste rules. For additional information refer to the Ohio EPA Fact Sheet "The Management of Fluorescent Lamps and PCB Ballasts in Ohio"

2. **Universal Waste Lamps, OAC 3745-273-14(E):** You failed to label spent lamps with the words "Universal Waste Lamp(s)" or "Waste Lamp(s)" or "Used Lamp(s)" that were stored in the corner.

This violation was abated during the inspection when labels for your lamps were made.

3. **OAC 3745-273-15(C) Accumulation time:** You failed to date or otherwise track the accumulation time of universal waste lamps.

This violation was abated during the inspection when lamp labels were dated.

4. **OAC 3745-273-13 (D)(1) Containers and packages must remain closed:** You failed to maintain spent lamps in closed boxes.

This violation was abated August 19, 2009 when the lamps were demonstrated properly contained.

Concerns

Aerosol cans and small containers are reported emptied and disposed with solid wastes. It is recommended that a management plan or training be implemented to ensure all containers are properly emptied or contents properly disposed. Some of your residual container contents could contain materials that are a characteristic or listed hazardous waste.

Regarding aerosol cans and other small containers, if the contents are used completely and the container is empty per OAC 3745-51-07(B)(2) the container may be disposed as a solid waste. Guidance regarding what is considered empty is attached: (Winter 2006 Notifier - Aerosol Can Questions and also found at:

<http://www.epa.state.oh.us/dhwm/pdf/NotifierWinter05.pdf>. The empty container may be recycled with other scrap metal. To insure cans are empty prior to disposal you may obtain a can crushing system that attaches to and captures residuals in a drum for later disposal. Otherwise, refer to manufacturer's information or MSDS data to determine whether the contents could be a hazardous waste and dispose accordingly.

Ohio EPA's Office of Compliance Assistance and Pollution Prevention (OCAPP) provides compliance and pollution prevention assistance on environmental issues related to air, land, and water. If desired, this can include an onsite assessment of your operations with a resulting report containing waste minimization and energy conservation suggestions.
