### NOTICE OF VIOLATION

Dear Mr. Peppers:

You are hereby notified that the Regional Air Pollution Control Agency (RAPCA) finds A.R. Environmental Inc. (A.R.) to be in violation of local asbestos regulations as they relate to proper notification procedures for asbestos abatement operations for seventeen projects throughout the city of Dayton, Ohio.

Montgomery County Hazardous Air Pollution Control Regulation 150 (MCHAPCR 150) governs over the demolition and renovation of all buildings, structures, installations, operations, which contains one or more source(s) of friable asbestos within Montgomery County. The purpose of MCHAPCR 150 is to protect the health and safety of the citizens of Montgomery County. The MCHAPCR 150 regulation is applicable to all institutional, commercial, industrial and apartment buildings and to all single and multi-family residences from which friable asbestos will be removed. Asbestos abatement activities involving the removal of fifty (50) square feet, linear feet, or any combination thereof, of friable asbestos is subject to MCHAPCR 150 and must be inspected for asbestos and notification must be submitted to RAPCA prior to the start of asbestos abatement activities.

A.R. performed asbestos abatement activities, of fifty feet or more, at each of the following structures without prior notification submitted to RAPCA:



The removal of asbestos at the above listed structures constitutes corresponding violations of MCHAPCR 153.06 (A) pertaining to proper notification procedures.

These violations can be resolved through the signing of the Administrative Settlement Agreement (Agreement) which includes a civil monetary penalty. The draft Agreement will be issued after receipt of this Notice of Violation. Please respond in writing within ten (10) days of receipt of the Agreement document if you wish to pursue a local settlement.
