WARNING LETTER


On June 20, 2007, the Regional Air Pollution Control Agency (RAPCA) received a complaint that open burning for waste disposal had occurred on your residence located at 3233 Ravenwood Drive, in Fairborn, OH. On June 27, 2007, a RAPCA representative performed an on-site inspection of the premises and observed a 10'x10' burnsite containing tree limbs and old stumps. This burnsite was located within one mile of the City of Fairborn and within 1,000 feet of neighboring residences.

Pursuant to Ohio Administrative Code (OAC) rule and Greene County Board of Health Air Pollution Control Regulations (GCBHAPCR) section 3745-19-03, **Open Burning in Restricted Areas**, open burning for residential waste disposal is prohibited within any municipal corporation, with a population of ten thousand persons or more, plus a zone extending one mile beyond any such municipality. Furthermore, open burning for waste disposal purposes is prohibited within 1,000 feet of neighboring residences anywhere in the state of Ohio.

Open burning for residential waste disposal purposes within a restricted area is a violation of OAC rule and GCBHAPCR section 3745-19-03. This letter serves as official notification from RAPCA to cease all open burning activities in violation of the state and local air regulations. **Any further violations of these regulations may result in enforcement actions against you, which include criminal and/or civil penalties.**
