WARNING LETTER

Dear Mr. Wilson:

The Regional Air Pollution Control Agency (RAPCA) has recently been reviewing our files to determine whether or not facilities are in compliance with requirements identified in permit terms and conditions. Upon review of Moyno Incorporated (Moyno) files, RAPCA identified that Moyno is in violation of the Permit To Operate (PTO) issued June 14, 2004. Moyno failed to submit the 1st and 4th quarterly reports as well as the 2006 annual reports for emissions units K005, K007, K009, K010, R002 and R005.

Per the PTO, Part II, Section D.3 Special Terms and Conditions, Moyno shall submit quarterly deviation reports in accordance with General Term and Condition 3.b which identify all exceedances of the rolling, 12 month emission limitation for each individual HAP.


Per the PTO, Part II, Section D.2 Special Terms and Conditions, Moyno shall submit annual reports which specify the individual HAP emissions from the facility, the combined HAP's emissions from the facility, and the total VOC emissions from each emissions unit.

Moyno is hereby notified of the failure to submit the above mentioned reports. The failure to submit the reports is a violation of the PTO and Ohio Revised Code (R.C.) 3704.05. RAPCA requests that Moyno submit the missing reports to RAPCA within 14 days of receipt of this letter.
