**WARNING LETTER**

Upon review of Jeff Wyler Body Shop's files, the Regional Air Pollution Control Agency (RAPCA) has recently determined that Jeff Wyler Body Shop has not submitted quarterly reports for the third and fourth quarters of 2006, first through fourth quarters of 2007, and first through third quarters of 2008, as required by permit terms and conditions for emissions units (EUs) K001 (Jupiter Paint Spray Booth), K002 (Atlantic Paint Spray Booth) and P001 (Prep Station).

Specifically, Part II.D.1 of the Permits to Operate (PTOs), issued on February 2, 2006, for EUs K001, K002 and P001 state that the permittee shall submit quarterly deviation (excursion) reports that:


(a) identify each month during which the rolling, 12-month individual facility hazard air pollutant (HAP) emission rate exceeded the 9.9 tons per year (tpy) rolling, 12-month individual facility HAP emission limitation, and the actual rolling, 12-month individual facility HAP emission rate for each such month.

(b) identify each month during which the rolling, 12-month combined facility HAP emission rate exceeded the 24.9 tpy rolling, 12-month combined facility HAP emission limitation, and the actual rolling, 12-month combined facility HAP emission rate for each such month.

The most current report on file is dated June 30, 2006 and was received by our office on August 7, 2006. Jeff Wyler Body Shop is hereby officially notified of the failure to submit quarterly reports, as required by PTO terms and conditions. Failure to submit these reports is a violation of the PTOs and Ohio Revised Code 3704.05. RAPCA requests that within thirty (30) days after receipt of this letter, Jeff Wyler Body Shop submit the required quarterly reports for EUs K001, K002 and P001 for the third quarter of 2006 through the third quarter of 2008 and a compliance plan to ensure that all future quarterly reports will be submitted in a timely manner.
