### WARNING LETTER

On February 1, 2011, the Regional Air Pollution Control Agency (RAPCA) conducted an inspection, as part of a Full Compliance Evaluation (FCE), of the Werner Enterprises, Inc. (Werner) facility located at 4395 Laybourne Road in Springfield, Clark County, Ohio. The purpose of this letter is to address and seek resolution to issues discovered during the course of the FCE pertaining to emissions unit (EU) K001 (Paint Spray Booth).

Pursuant to Part II.D (**Reporting Requirements**) of Permit-to-Install (PTI) 08-04535, issued January 15, 2004, and the Permit-to-Operate (PTO), issued February 2, 2006, Werner is required to submit annual reports which specify the total volatile organic compounds (VOC) emissions from EU K001 for the previous calendar year by January 31 of the following year. As of the February 1, 2011 FCE, Werner had not submitted the required annual reports for the 2006 through 2010 calendar years, although RAPCA observed that Werner is maintaining all required records per the permit terms and conditions. On February 17, 2011, Werner submitted all past due annual reports for EU K001 via email. **Failure to submit the required annual reports by the due date is a violation of PTI 08-04535, the PTO and Ohio Revised Code (ORC) 3704.05.**

Additionally, the PTO requires that Werner submit a complete renewal application for EU K001 no later than 180 days prior to the expiration date of the PTO. The current PTO expired on February 2, 2011. Therefore, a renewal application should have been submitted no later than August 6, 2010. RAPCA has yet to receive a renewal application from Werner for EU K001. At this time RAPCA requires that Werner submit a renewal application for EU K001.


