WARNING LETTER

Dear Mr. Burgess:

On June 1, 2007, the Regional Air Pollution Control Agency (RAPCA) received a referral from the Clark County Combined Health Department regarding illegal open burning at 8393 Lower Valley Pike, New Carlisle, Ohio. The referral stated during a May 15, 2007 inspection, you informed the Clark County Combined Health Department that you had disposed of waste by open burning. The purpose of this letter is to inform you of the open burning regulations applicable in your area.

Pursuant to Ohio Administrative Code (OAC) rule and the Clark County Combined Health Department Air Pollution Control Regulation (CCCHDAPCR) 3745-19-04, Open burning in unrestricted areas, open burning for waste disposal purposes is prohibited at commercial, non-profit, and government entities. Only residential and agricultural properties are permitted to open burn under the OAC and CCCHADPCR rules. I have enclosed a copy of the open burning rules for your review.

You are hereby ordered to immediately cease all illegal open burning activity. Future violations of the open burning rule may result in enforcement action, including civil penalties, being taken. If you have any questions regarding the open burning rules, please contact me at 937-225-4004.
