WARNING LETTER

Dear Mr. Spradlin:

On June 25, 2008, the Regional Air Pollution Control Agency (RAPCA), received two complaints regarding illegal open burning of commercial waste at 2131 Quality Lane, Springfield, Ohio. On June 26, 2008, RAPCA investigated the complaint and found a 5x5 ft burn site that contained wood and tree limbs at Spradlin Brothers.

Pursuant to Ohio Administrative Code (OAC) rule and the Clark County Combined Health District Air Pollution Control Regulations (CCCHDAPCR) 3745-19-03, Open burning in restricted areas, open burning of commercial waste for the purpose of waste disposal is prohibited. The open burning documented on June 26, 2008 by RAPCA is a violation of OAC rule and CCCHDAPCR rule 3745-19-03. Orders were issued to the Plant Manager at the time of the investigation.

This letter serves as notification to you of the above mentioned violations. You are hereby ordered to cease all illegal open burning activities. This is the second such violation. RAPCA also investigated a complaint on April 24, 2007 and issued Orders at that time for open burning for waste disposal at a commercial business. *Any further actions in violation of the above mentioned rules may result in an enforcement action with civil and/or criminal penalties.* If you have any questions, please contact me at 937-225-4004.
