WARNING LETTER

The Regional Air Pollution Control Agency (RAPCA) received a complaint on April 10, 2010, regarding open burning being conducted at 4435 Detrick-Jordan Pike in German Township, Clark County, Ohio. Research conducted by RAPCA has determined that you are the property owner and therefore responsible for the open burning conducted at this location. RAPCA performed an inspection of the premises on April 15, 2010. During the time of RAPCA's inspection, open burning was occurring. RAPCA observed a large burn pile (approximately 8' X 8') containing unknown material. The burn site was located in an unrestricted area within 1,000 feet of several neighboring residences. This open burning is in violation of the following state and local air pollution control regulations:


- * Ohio Administrative Code (OAC) rule: 3745-19-04, Open Burning in Unrestricted Areas.
- * Clark County Combined Health District Air Pollution Control Regulations (CCCHDAPCR) rule: 3745-19-04, Open Burning in Unrestricted Areas.

Pursuant to the above regulations, open burning for the purpose of waste disposal must be conducted at least 1,000 feet from the nearest neighboring residence or inhabited building. Additionally, items containing rubber, grease, asphalt or petroleum products (such as plastics) and garbage (any matter resulting from food preparation and/or consumption) are strictly prohibited from being burned anywhere in the state of Ohio.

This letter serves as official notification to cease all open burning in violation of the aforementioned regulations. Any further violations of the regulations will result in enforcement actions against you which could include criminal and/or civil penalties.
