WARNING LETTER

On January 19, 2007, the Regional Air Pollution Control Agency (RAPCA) received a complaint regarding an open burning incident on the property located at 6318 US Route 40 East, Lewisburg, Ohio that occurred on 2/26/2006. The Lewisburg Fire Department was dispatched to your property to extinguish the fire. At that time, a representative of the fire department informed you of the open burning regulations. The open burning that occurred on 2/26/2006 was in violation of the following state air pollution control regulation:

- ★ Ohio Administrative Code (OAC) rule: 3745-19-04,
Open Burning in Unrestricted Areas.

Pursuant to the above cited regulation, open burning of any materials, including brush and wood, for the purpose of waste disposal within 1,000 feet of any inhabited building not located on the premises is strictly prohibited in the state of Ohio. This letter serves as official notification to cease all open burning in violation of the aforementioned regulation. In the future, an alternative means of disposal must be employed.


