WARNING LETTER

Dear Mr. & Mrs. Bishop:

On April 7, 2008, a representative from the Regional Air Pollution Control Agency (RAPCA) observed open burning on the property located at 10139 Greenwood Road, Middletown, Ohio in Preble County. The burn pile contained carpet, treated wood and other miscellaneous debris. This open burning is in violation of the following state air pollution control regulation:

- ★ Ohio Administrative Code (OAC) rule: 3745-19-04,
Open Burning in Unrestricted Areas.

Pursuant to the above cited regulation, the open burning of the aforementioned materials and burn location is strictly prohibited in the state of Ohio. This letter serves as official notification of the aforementioned violation and to cease all unauthorized open burning activities immediately. Any further violations of the regulations may result in enforcement actions against you which could include criminal and/or civil penalties.


