WARNING LETTER

Dear Mr. & Mrs. John Haberny:

On April 18, 2008, a representative from the Regional Air Pollution Control Agency (RAPCA) was performing routine surveillance in Preble County and observed open burning occurring on your property at 10378 State Route 503, Camden, Ohio. At the rear of the property, there was a burn site containing branches and grass. This open burning is in violation of the following state air pollution control regulations:

- ★ Ohio Administrative Code (OAC) rule: 3745-19-04,
Open Burning in Unrestricted Areas.

During the inspection, the RAPCA representative spoke with you and explained that open burning for waste disposal purposes within 1000 feet of an inhabited residence is strictly prohibited. This letter serves as official notification of the aforementioned violation and to cease all unauthorized open burning activities.


