WARNING LETTER

On July 17, 2008, the Regional Air Pollution Control Agency (RAPCA) received an incident report from the West Alexandria Fire Department regarding open burning at the property located at Twin Road (Parcel #H25530810100008000), West Alexandria, Ohio in Preble county. A RAPCA representative inspected the site on July 17, 2008. It was observed and documented that open burning in violation of Ohio Administrative Code (OAC) rule 3745-19-04, Open Burning in Unrestricted Areas, had occurred.

On July 25, 2008, RAPCA received information that further open burning had occurred on July 23, 2008. Per OAC 3745-19-06, RAPCA may assess and collect administrative penalties from any person who violates any of the rules in this chapter. Through unilateral orders, the director may assess one thousand dollars per day for each separate violation of the rules in this chapter.

This letter serves as official notification to immediately cease all open burning in violation of the aforementioned regulation. In the future, an alternative means of disposal must be employed. Any further violations of the regulations could result in enforcement actions which could include criminal and/or civil penalties.
