WARNING LETTER

On May 24, 2011, the Regional Air Pollution Control Agency (RAPCA) received information from the Camden Somers Township Fire Department regarding open burning on the property located at 709 Rose Boulevard, Camden, Ohio in Preble County. A RAPCA representative investigated the complaint on May 26, 2011. RAPCA documented that a mobile home was demolished and evidence of open burning for waste disposal purposes had occurred on the property. This open burning is in violation of the following state air pollution control regulations:


- Ohio Administrative Code (OAC) rule 3745-19-04 Open Burning in Unrestricted Areas
- Ohio Revised Code (ORC) 3704.05

Pursuant to the above cited regulations, the open burning of any materials, including wood, for the purpose of waste disposal on this property is strictly prohibited by the State of Ohio. This letter serves as official notification to cease all open burning in violation of the aforementioned regulations. In the future, an alternative means of disposal must be employed.

Any violations of the regulations could result in enforcement actions which could include criminal and/or civil penalties. The determination whether to pursue or not to pursue penalties will be made at a later date. The disposal of the remaining materials shall comply with all applicable air and solid waste regulations.
