### WARNING LETTER

Dear Mr. Harmon:

On May 1, 2008, the Regional Air Pollution Control Agency (RAPCA) received a notice from the Miami Twp. Fire Department regarding complaints of open burning at 7332 Upper Miamisburg Rd., Miamisburg, OH.

On May 1, 2008, I visited this site and discussed the open burning complaint with you. Evidence of open burning was documented, including the charred remains of rubbish. Open burning in a restricted area is a violation of Ohio Administrative Code (OAC) and Montgomery County Combined General Health District Air Pollution Control Regulations (MCCGHDAPCR) 3745-19-03. A restricted area is an area within the boundary of any municipal corporation, plus a zone extending one mile beyond any such municipal corporation.

This letter serves as a warning from the Regional Air Pollution Control Agency to cease all open burning in violation of both state and local air pollution control regulations. Further verified open burning complaints could result in civil and/or criminal penalties.

In the future, alternative means of disposal must be employed.
