WARNING LETTER

Dear Mr. Abner:

On June 15, 2010, the Regional Air Pollution Control Agency (RAPCA) received an incident report from the Miamisburg Fire Department regarding the open burning of wood and brush at 424 Mound Ave., Miamisburg, OH. The open burning of this material for waste disposal in a restricted area is a violation of Ohio Administrative Code (OAC) and Montgomery County Combined General Health District Air Pollution Control Regulations (MCCGHDAPCR) 3745-19-03. A restricted area is an area within the boundary of any municipal corporation, plus a zone extending one mile beyond any such municipal corporation.

This letter serves as a warning from the Regional Air Pollution Control Agency to cease all open burning in violation of both state and local air pollution control regulations. In the future, alternative means of disposal must be employed.

Failure to comply with the above reference regulations could result in civil and/or criminal penalties as provided for in the Ohio Revised Code Sections 3704.05 and 3707.48.
