WARNING LETTER

Dear Mr. Grill:

On July 12, 2011, the Regional Air Pollution Control Agency (RAPCA) received a citizen complaint concerning the large scale open burning of brush at **40 N. Meadow Drive, Trotwood, Ohio**. It was discovered that the Trotwood Fire Department responded to this residence on July 13, 2011 and verified that the burning of brush for waste disposal was occurring.

The open burning of brush for waste disposal is prohibited in the State of Ohio and is a violation of Ohio Administrative Code (OAC) and Montgomery County Combined General Health District Air Pollution Control Regulations (MCCGHDAPCR) 3745-19-03 "Open Burning in a Restricted Area". A restricted area is an area within the boundary of any municipal corporation, plus a zone extending one mile beyond any such municipal corporation.

This letter serves as a warning from the Regional Air Pollution Control Agency to cease all open burning in violation of both state and local air pollution control regulations. In the future, alternative means of disposal must be employed.

Any further violations of the above referenced rules may result in enforcement action which may include criminal and /or civil penalties.
