**WARNING LETTER**

Dear Mr. Davis:

On April 3, 2007, the Regional Air Pollution Control Agency (RAPCA) received a citizen complaint open burning of wood and trash on your property located at 6122 12<sup>th</sup> Ave, Miamisburg, Ohio. A RAPCA inspection of this property resulted in evidence to support this complaint. This type of open burning in a restricted area is a violation of Ohio Administrative Code (OAC) and Montgomery County Combined General Health District Air Pollution Control Regulations (MCCGHDAPCR) 3745-19-03. A restricted area is an area within the boundary of any municipal corporation, plus a zone extending one mile beyond any such municipal corporation.

This letter serves as a warning from the Regional Air Pollution Control Agency to cease all open burning in violation of both state and local air pollution control regulations. In the future, alternative means of disposal must be employed. Any future illegal burning may result in enforcement action which may include civil and criminal penalties.
