WARNING LETTER

Dear Mr. Morgan:

On July 25, 2007, the Regional Air Pollution Control Agency (RAPCA) received a incident report from the New Lebanon Fire Department regarding the open burning of wood and rubbish at 14230 Eaton Pike, New Lebanon, OH. July 20, 2007. The open burning of these materials in a restricted area is a violation of Ohio Administrative Code (OAC) and Montgomery County Combined General Health District Air Pollution Control Regulations (MCCGHDAPCR) 3745-19-03. A restricted area is an area within the boundary of any municipal corporation, plus a zone extending one mile beyond any such municipal corporation.

This letter serves as a warning from the Regional Air Pollution Control Agency to cease all open burning in violation of both state and local air pollution control regulations. In the future, alternative means of disposal must be employed. Any future violations may result in enforcement activity which may include civil and/or criminal penalties.
