Dear Mr. Wysong:

The Regional Air Pollution Control Agency (RAPCA) has recently been reviewing our files to determine whether or not facilities are in compliance with any reporting requirements identified in permit terms and conditions. Upon review of Wysong Stone Company files, RAPCA identified that the permit for air emissions units F002, F003, F004 and F005 requires that an Annual Permit Evaluation Report (PER) be submitted to RAPCA.

Per Emissions Unit Terms and Conditions, 2.e.2., of Permit to Install and Operate issued 9/3/2009, a PER must be submitted by February 15 of each year.

Wysong Stone Company is hereby notified of the failure to submit the PER for emissions units F002-F005. The failure to submit the PER is a violation of the PTIO and Ohio Revised Code (R.C.) 3704.05. RAPCA requests that Wysong Stone Company submit the missing PER within 14 days of receipt of this letter. Also, Wysong Stone Company is required to maintain records as specified in Emissions Unit Terms and Conditions 2.d.1 and 2. of the PTIO.
