WARNING LETTER

Dear Mr. Martin:

On July 31, 2007, the Regional Air Pollution Control Agency (RAPCA) received Avery Dennison-Monarch's second quarter deviation report. The report did not contain the required language or signature of the responsible official. Per Part I, General Terms and Conditions, Section A.12.a., of the TV operating permit issued 10/24/2001, any document (including reports) required to be submitted and required by a federally applicable requirement in this Title V permit shall include a certification by a responsible official that, based on information and belief formed after reasonable inquiry, the statements in the document are true, accurate, and complete.


In addition, RAPCA has not received Avery Dennison-Monarch's semiannual report covering the time period from January 1 to June 30, 2007. Per Part I, General Terms and Conditions, Section A.1.c.iii., of the TV operating permit, written reports, which identify any deviations from the federally enforceable monitoring, recordkeeping, and reporting requirements contained in this permit shall be submitted to RAPCA every six months, i.e., by January 31 and July 31 of each year for the previous six calendar months. These semiannual written reports shall satisfy the requirements of OAC rule 3745-77-07(A)(3)(c)(i) and (ii) pertaining to the reporting of any deviations related to the monitoring, recordkeeping, and reporting requirements. If no deviations occurred during a six-month period, Avery Dennison-Monarch shall submit a semi-annual report, which states that no deviations occurred during that period.

Avery Dennison-Monarch shall resubmit the quarterly deviation report with the required responsible official signature and submit a semiannual report. Please note that the reports will be considered late and must be documented as such on the annual compliance certification.
