WARNING LETTER

Dear Ms. Kocol:

The purpose of this letter is to inform Capitol Cleaners #191 located at 760 West National Road, Vandalia, Ohio in Montgomery County, Ohio and identified by Ohio EPA facility identification number 0857173075 that the Permit to Operate issued 03/13/2002 for emissions unit D001 expired at midnight on 03/13/2007. Capitol Cleaners #191 was required to submit a PTO renewal application no later than one-hundred eighty (180) days prior to the expiration date. To date, the Regional Air Pollution Control Agency (RAPCA) has not received a renewal application.

Capitol Cleaners #191 is currently operating under an expired PTO, in violation of Ohio Administrative Code (OAC) and Montgomery County Combined General Health District Air Pollution Control Regulations (MCCGHDAPCR) rules 3745-35-02 and Ohio Revised Code (ORC) § 3704.05. RAPCA requests that within 30 days of receipt of this letter, Capitol Cleaners submit a complete renewal application.
