### **WARNING LETTER**

Dear Mr. Beirise:

On June 22, 2007, the Regional Air Pollution Control Agency (RAPCA) received a complaint regarding the open burning of railroad ties at 4406 Dinsmore Dr, Tipp City, Ohio. On June 25, 2007, an inspection was performed and RAPCA found a burn site approximately 6 x 6 feet containing a railroad tie, a tree stump, partially burned paper, paper ash, and miscellaneous metal.

Pursuant to Ohio Administrative Code (OAC) rule and the Miami County Board of Health Local Air Pollution Control Regulations (MCBHLAPCR) 3745-19-03, Open burning in restricted areas, open burning of residential waste, including yard waste, treated lumber, metal, etc., for waste disposal purposes is prohibited. The open burning documented on June 25, 2007 was in violation of OAC rule and MCBHLAPCR rule 3745-19-03.

This is the second complaint within a month RAPCA has received regarding illegal open burning at this address. On June 4, 2007, RAPCA performed an inspection and met with you. During that meeting, you were informed of the open burning rules and a follow-up letter was mailed on June 4, 2007. Additionally, a review of RAPCA's files indicates that in 1998 RAPCA inspected this property and issued Orders for open burning violations.

You are hereby ordered to immediately cease all illegal open burning. Any further actions in violation of the above mentioned rules may result in an enforcement action with civil and/or criminal penalties. If you have any questions, please contact me at 937-225-4004.




