WARNING LETTER

Dear Mr. Beirise:

On August 28, 2007, the Regional Air Pollution Control Agency (RAPCA) received a complaint regarding the illegal open burning 4406 Dinsmore Dr, Tipp City, Ohio. That same day, an inspection was performed and RAPCA found a burn site approximately 6 x 6 feet containing evidence of burned yard waste.

Pursuant to Ohio Administrative Code (OAC) rule and the Miami County Board of Health Local Air Pollution Control Regulations (MCBHLAPCR) 3745-19-03, Open burning in restricted areas, open burning of residential waste, including **yard waste**, treated lumber, metal, etc., for waste disposal purposes is prohibited. The open burning documented on August 28, 2007 was in violation of OAC rule and MCBHLAPCR rule 3745-19-03.

This is the third complaint within three months that RAPCA has received regarding illegal open burning at this address. On June 4, 2007, RAPCA performed an inspection and met with you and discussed the rules. On June 22, 2007, RAPCA received a second complaint and performed an inspection. A Warning Letter was mailed on June 25, 2007. This is the second and final warning you will be given, any future open burning in violation of the rules will result in enforcement action with civil and/or criminal penalties.
