JAH, Inc. is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring.

2. Complete the enclosed Verification Form within 10 days of issuing the Public Notice and mail it to Ohio EPA - Northeast District Office. Include a copy of each notice distributed, published or posted.

If total coliform samples were collected as required, submit the results as soon as possible. The monitoring violation would be rescinded and a reporting violation given for late submittal of the results.
