**NOTICE OF VIOLATION – ACTION REQUIRED**

**Subject: Failure to Sample Drinking Water for Total Coliforms as Required**

ROCK OF GRACE CHURCH is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring.

**Monitoring Period:** July-September 2008  
**Required Coliform Monitoring:** 1 per Quarter  
**Sample Results Submitted:** 0

To ensure the safety of drinking water provided by your system monitoring for total coliforms is essential.

**ACTION REQUIRED:**

1. **Notify the people served by this water system** using one or more of the methods and the timing as required by OAC, Rule 3745-81-32 to reach all persons served.


<b>Transient or Non Transient Non Community</b>	
<b>Timing:</b>	As soon as practical, but no later than 30 days after learning of the violation:
<b>Methods:</b>	<ul style="list-style-type: none"> <li>• Posting in conspicuous location, such as bulletin boards, restrooms, drinking fountains, vending areas</li> <li>• Mail or other direct delivery to each customer</li> <li>• Newsletters or newspaper</li> <li>• E-mail to employees or students</li> <li>• Send to parents or guardians of children at schools or day care facilities</li> </ul>
Posted notices must remain in place as long as the violation or situation exists, but in no case less than seven days (even if the violation is resolved). The language in italics on the enclosed public notice is mandatory and must be included, as written. Do not make changes to the public notice without consulting with the Ohio EPA beforehand.	

2. **Complete the enclosed Verification Form within 10 days of issuing the Public Notice** and mail it to Ohio EPA – Northeast District Office along with a copy of the public notice as distributed. Be sure to return BOTH the public notice AND the verification form. If you prefer, you may fax the public notice AND completed verification form to the attention of Charlotte Hammar - fax # (330) 963-4760.

If total coliform samples were collected as required, submit the results as soon as possible to this office. The monitoring violation will be rescinded; however, the reporting violation remains for submitting the results late.
