DOUGHTON GOLF COURSE is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring.

Monitoring Period: July-September 2008
Required Coliform Monitoring: 1 per Quarter

Be sure to return BOTH the public notice AND the verification form. If you prefer, you may fax the public notice AND completed verification form to the attention of Charlotte Hammar - fax # (330) 963-4760.

If total coliform samples were collected as required, submit the results as soon as possible to this office. The monitoring violation will be rescinded; however, the reporting violation remains for submitting the results late.
