Your public water system is in violation of Rule 3745-81-21 of the Ohio Administrative Code for failure to comply with the coliform monitoring requirements:



Actions required as a result of the above violation	
Step 1	<p>Within 30 days issue the attached public notice of the violation in accordance with rule 3745-81-32 of the Ohio Administrative Code by the following methods:</p> <ol style="list-style-type: none"> 1. Continuous posting, mail, or other direct delivery; and 2. If necessary, the system must also use any other method reasonably calculated to reach all persons served by the public water system. <p><i>The language in italic on the attached public notice is mandatory language and must be included as written.</i></p>
Step 2	<p>Within ten (10) days of completing Step 1 above, fill out the attached verification form and send along with a copy of the public notification issued to the District Office of the Ohio EPA.</p>

If samples were taken, we have not received the results. Please forward a copy of the results to my attention. Late reporting is a reporting violation but if the sample was taken and a result obtained, you will not need to issue the attached public notice.
