Dear Mr. Thomas:

Your public water system is in violation of Rule 3745-81-21 of the Ohio Administrative Code for failure to comply with the coliform monitoring requirements:

#### Actions required as a result of the above violation

Step 1	<p><b>Within 30 days</b> issue the attached public notice of the violation in accordance with Rule 3745-81-32 of the Ohio Administrative Code by the following methods:</p> <ol style="list-style-type: none"> <li>1. Mail or other direct delivery to each customer receiving a bill and to other service connections; and</li> <li>2. If necessary, the system must also use any other method reasonably calculated to reach all persons served by the public water system.</li> </ol> <p>Note: Systems opting to include the required public notice in the next water bill have up to 90 days. <i>The language in italic on the attached public notice is mandatory language and must be included as written.</i></p>
