Dear Ms. Siegfert:

Your public water system is in violation of Rule 3745-81-21 of the Ohio Administrative Code for failure to comply with the coliform monitoring requirements:

Step 1	<p><b>Within 30 days</b> issue the attached public notice of the violation in accordance with rule 3745-81-32 of the Ohio Administrative Code by the following methods:</p> <ol style="list-style-type: none"> <li>Continuous posting, mail, or other direct delivery; and</li> <li>If necessary, the system must also use any other method reasonably calculated to reach all persons served by the public water system.</li> </ol> <p><i>The language in italic on the attached public notice is mandatory language and must be included as written.</i></p>

Step 2	Within ten (10) days of completing <b>Step 1</b> above, fill out the attached verification form and send along with a copy of the public notification issued to the District Office of the Ohio EPA.

The school is closed from May through August. However, because the school was open in April, a routine quarterly bacteria sample must be collected during that month to achieve compliance with monitoring requirements for the April - June quarter. A sample must again be collected in September to comply with monitoring requirements for the July - September quarter.
