Continuous posting, mail, or other direct delivery; and</li> <li>2. If necessary, the system must also use any other method reasonably calculated to reach all persons served by the public water system.</li> </ol> <p><i>The language in italic on the attached public notice is mandatory language and must be included as written.</i></p>
Step 2	<p>Within ten (10) days of completing <b>Step 1</b> above, fill out the attached verification form and send along with a copy of the public notification issued to the District Office of the Ohio EPA.</p>
