Dear Mr. Tracht,

On March 7, 2012, I conducted a compliance evaluation inspection at Angie's Body & Frame, Inc. (Angie's) located at 121 North Pleasant Street in Norwalk, Ohio. I inspected Angie's to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). Pollution prevention options were also discussed during this inspection. This letter will explain the violations I found and what, if anything, you need to do to correct these violations.

During my visit I spoke with you and Charles Hensley, observed your operations and reviewed paperwork. Angie's specializes in automotive body work and collision repairs. Angie's switched over to using PPG Envirobase waterborne paint and has significantly reduced the amount of hazardous waste paint solvent generated. In addition, Angie's uses an on-site solvent still unit to recycle the waste paint solvent generated when the paint lines are flushed thus decreasing the amount of waste generated and the amount of solvent purchased.

Angie's does painting on-site and generates still bottoms (D001, F003, F005) from the operation of the on-site solvent recycling still. Angie's cleans the paint spray guns by hand and adds the spent solvent into a satellite container located in the paint mixing area until it is added to the solvent still. Angie's has one waterborne paint booth and changes the filters as specified by the manufacturer. The spent waterborne paint booth filters are managed as a solid waste. Used oil is stored in a 55-gallon drum and picked up by Heritage/Crystal Clean and burned for energy recovery. Spent fluorescent lamps are managed as universal waste.

Angie's notified as a small quantity generator of hazardous waste, however, at the time of my inspection, Angie's was operating as a conditionally exempt small quantity generator of hazardous waste.

1. OAC Rule 3745-273-13(D)(1): Universal Waste: Fluorescent Lamp Management:

All lamps/bulbs being managed as a universal waste must be stored in packages that are structurally sound and adequate to prevent breakage. The packages/containers must be closed.

Angie's did not store the spent universal waste fluorescent bulbs in containers that were closed.

At the time of my inspection, Angie's properly closed the box of spent universal waste fluorescent bulbs.

Therefore, this violation is considered abated.

2. OAC Rule 3745-273-14(E): Universal Waste: Fluorescent Lamp Labeling:

All packages and containers holding spent fluorescent lamps/bulbs are to be labeled with the words "Universal Waste - Lamps", "Waste Lamps" or "Used Lamps".

Angie's did not have the spent universal waste fluorescent bulbs properly labeled.

At the time of my inspection, Angie's properly labeled the box of spent universal waste fluorescent bulbs.

Therefore, this violation is considered abated.

3. OAC Rule 3745-273-15(C): Accumulation Time for Universal Waste Batteries and Lamps:

A small quantity handler of universal waste shall be able to demonstrate the length of time that the universal waste has been accumulated from the date it becomes a waste or is received.

Angie's was unable to demonstrate the length of time the spent universal waste fluorescent bulbs have been on-site. Angie's was able to demonstrate when the universal waste was last shipped off-site, but was not tracking the date when the accumulation began.

At the time of my inspection, Angie's properly labeled the box of spent universal waste fluorescent bulbs with the accumulation start date.

Therefore, this violation is considered abated.
